Advisory Committee Accomplishments for 2015

From previous columns in *The Wine Press*, you may recall that the primary goals of the Advisory Committee (AC) are (1) to prepare the community for the eventual turnover of governance of Britton Falls to an HOA Board comprised of elected representatives of homeowners and (2) to advise Pulte, through the current HOA Board and Community Management Services, on activities within, and needs of, the community. To that end, perhaps the AC's most important accomplishment of 2015 was the restructuring of the AC into the following working Subcommittees: Communications, Community Quality, Facilities and Grounds, Finance, Government Relations, Safety, and Transition and Document Review. Each subcommittee is chaired by a member of the Advisory Committee with some of the subcommittees including resident members from throughout the community.


Through the initiative of the Advisory Committee and its Subcommittees, and with the cooperation and collaboration of Pulte and Community Management Services, as well as Fishers and Hamilton County officials, the following represents a partial list of the AC's major accomplishments:

- Completed a comprehensive review of the governing documents for Britton Falls
- Secured funding from the HOA Board to hire legal counsel to assist the AC in the

- transition process from a builder-controlled HOA to a homeowner-controlled HOA
- In collaboration with the HOA Board, the Finance Subcommittee continued to provide oversight on both budgeting and spending, and initiated a review of the community "repair and replacement reserve balance" to insure the community will be financially prepared for the eventual transition to a Homeowner HOA
- Initiated formal collaboration with Pulte in the construction of an "annex" building designed to serve the needs of the growing community
- Initiated the development and articulation of "community wide standards" designed to establish guidelines for the maintenance/replacement/funding of critical community assets (structures, recreational facilities, common amenities, etc.)
- Secured the planting of trees along the south side of Del Webb Parkway
- In support of the Britton Falls Pickleball Committee and in collaboration with the City of Fishers, secured the addition of four pickleball courts in Cyntheanne Park
- In collaboration with Pulte and the City of Fishers, secured exemption allowing Britton Falls to be designated a "golf cart community"

- In response to the requests of Britton Falls residents, initiated dialogue between the City of Fishers and Pulte leading to the repaying of Atlantic Avenue
- Established a Welcome Committee to greet new residents and provide information about available community resources
- Initiated The Wine Press as a periodic newsletter to inform the community of activities and accomplishments of the Advisory Committee, as well as HOA Board, Pulte, city and county updates related to the Britton Falls community.
